You know this is only country in the world where you pay taxes honest. Other countries are graft," he declared, nervously gesturing with hand behind back as he sat with his feet up.

"Like I told the reporters in Italy, They asked me where all this money goes I pay in taxes. I told them 'I don't know. It's all of it. It's going to the March of dimes. I'm glad you're getting it. Only why you complain? We're not the ones that are paying the money."

Opinions of Portlanders On Mercy Killing Varied

Although one of two Portlanders held that so-called "mercy killing" is not justified, four of five voted in favor of its being allowed in the case of the incurably ill. Significantly, euthanasia received its strongest support among persons over 40 years of age.

The proposed case of Dr. Hermann N. Sander, Manchester, N. H., physician who was recently acquitted of the charge of taking the life of one of his patients who was suffering from an incurable cancer, brings once more to the fore the age-old problem of "mercy killing." Is it ever justified, no, with whom?

Front Door Poll. Interviewers found Portlanders divided on the issue; five out of ten feel mercy killing is never justified, four out of ten feel that it may be justified under special circumstances, and the remaining one in ten is undecided.

"People must maintain confidence by helping people to live, not die!" exclaimed one woman. "While there is hope, there is hope!" emphatically declared another woman opposed to euthanasia.

Here's how they answered the question: "Do you or do you not think mercy killing is ever justified?"

Never justified 51%
May be justified 45%
Undecided 14%

Men and women agreed on the issue, but there was a marked split between persons under 40 years of age and those over 40.

21 to 39 40 and Over

When is mercy killing justified? Here are the conditions under which those who think it may sometimes be justifiable feel that it should be done:

When patient is beyond recovery; incurable; hopeless; when suffering is great; patient in agony; no drug relief; only a doctor's opinion by board of doctors; at patient's request; Other reasons

72% 12% 18% 2% 104%

*Answers total more than 100% because some people gave more than one reason.

It will be noted that although only 18 per cent actually mentioned that a board of doctors should decide, the answers given by the others ("when patient is beyond recovery; when there is no drug relief," etc.) indicates that many of them feel that some qualified person or persons should make the decision.
